Induction and Training

The Trust's legal advisors draw the attention of prospective new trustees to the Charity Commission guidance on the responsibilities of Trustees prior to their acceptance of the role. New Trustees also receive a copy of the Trust Deed.

The Charity Commission and other bodies from time to time issue regulatory updates and advisory guidance to Charities. The implications of such updates and guidance are discussed at Trustees' meetings.

Major Risks

The Trustees consider that the major risks to the charity are currently:

- **Fiduciary.** The Trust's assets are predominantly cash on bank deposit. These funds are subject to the protection of the Financial Services Compensation Scheme. In the opinion of the Trustees, the financial controls in place safeguard cash receipts and payments.
- **Reputational.** The Trustees at all times adhere to the core values of openness, transparency and integrity. All fundraising events are designed with equal weighting to raise money for the Trust and to provide a safe and enjoyable experience for the participant.
- **Public Liability.** Risks of bodily injury or damage to non-owned property arising from fundraising activities are mitigated by risk assessments and insurance.
- **Medical Advice.** The Trust does not offer medical advice.
- **Changes within the NHS.** The Trust's major activity is to fund the development of new posts within the NHS to support children with arrhythmias and their families. The continuing agenda for change in the NHS, particularly within the area of Congenital Heart Disease, creates a risk that the Trust funds a role that becomes a casualty of that change. As a condition of funding the new Clinical Psychology post at the Royal Brompton Hospital, the Trustees have sought and received a guarantee the hospital will adopt the post after two years.

Summary of the objects of the charity set out in its governing document

Ben Williams was a warm hearted, talented and cheerful boy with a love of all sport and a particular passion for cricket. A keen wicketkeeper and batsman, he played for Haslemere Preparatory School, the Royal Grammar School in Guildford and Grayswood CC, and he represented West Surrey and Surrey from the U9 age group onwards. He went on tour with Surrey to Holland in 2000 and Perth, Australia in 2004. Ben was very much a team player, always encouraging others, and he enjoyed coaching and helping those younger than himself.

At the age of 14 he was found to have a heart arrhythmia, which resulted in him having to stop all forms of sport and physical activity. He died five months later in February 2006 shortly after collapsing at school. It was subsequently determined that he had a rare heart muscle disorder.

The Trust has been set up in Ben's memory. Its objects are:

- To relieve sickness and preserve the health of children and young people suffering from heart muscle disorders, for example by:
 - Providing or assisting in the provision of equipment facilities and services not normally provided by the statutory authorities
 - Sponsoring and helping to develop nursing posts and other mechanisms of support for children and young people with heart disorders and their families
 - Supporting the development of the Royal Brompton hospital as an epicentre of excellence and the forging of links with other institutions
 - Supporting improved pathology for cases of sudden death in children and young people
 - Raising awareness of heart muscle disorders in children and young people
 - Supporting research into the diagnosis control and treatment of heart muscle disorders in children and young people
 - Supporting the development and provision of resource centres for information on heart muscle disorders in children and young people.
- To provide or assist in the provision of facilities, equipment and coaching for children and young people to play cricket;

Whilst the cricketing related objects of the Trust are broad, the Trustees are most keen to support the development of young wicket-keepers.

Statement on Public Benefit

The objects of the Trust are realised through the making of grants to appropriate organisations. The Trustees confirm that they have reviewed the Trust's aims and objectives and all activities having regard to the guidance issued by the Charity Commission on public benefit.

Paediatric cardiac electrophysiology nurse specialist post at the Royal Brompton Hospital, London

The Trust funded the creation of a new paediatric cardiac electrophysiology nurse specialist post at the Royal Brompton Hospital, London, known as "Ben's Nurse". After being supported by the Trust for three years, the post now has statutory funding and has been seen as a role model for the development of the Royal Brompton's cardiac nurse specialist service.

Paediatric clinical psychologist post at the Royal Brompton Hospital, London

As a natural extension of the nurse specialist post and as detailed later in this report, the Trust has funded the creation of a new clinical psychology post for two years with effect from 1 April 2014. Working as part of the multi-disciplinary team, the object of the role is to promote psychological well-being, offer support and help with any psychological problems that may arise either with the child or with their family during the period of investigation and following diagnosis. As with Ben's Nurse, the aim is to help those impacted to live as normal a life as possible. The post also includes an element of research into how the provision of psychological support can be improved, with proactive rather than reactive intervention.

Development courses for young wicket-keepers

During the year under review, the Trust funded a wicket-keeping development programme for the Hampshire Cricket Board, providing otherwise unavailable access to specialist wicket keeping coaching for 28 boys and girls across a range of ages, helping them to improve their skills, fitness and confidence.

Summary of the main achievements of the charity during the year

Activities Undertaken for the Public Benefit

Paediatric Clinical Psychologist

The post of Ben's Nurse has been fully established as a key component of the children's cardiac electrophysiology services provided by the team at the Royal Brompton. It now receives statutory funding and has been a role model for the expansion of the Royal Brompton's cardiac nurse specialist service.

With effect from 1 April 2014, Dr Hannah Levy was appointed as the Ben Williams Trust paediatric clinical psychologist at the Royal Brompton Hospital. Hannah has worked alongside the current team of professionals with children and their families to promote psychological well-being, offer support and to help with any psychological problems that may arise. As with Ben's Nurse, the aim is to help those impacted to live as normal a life as possible. Hannah is also undertaking research into how the provision of psychological support can be improved, with proactive rather than reactive intervention.

Examples of situations where the clinical psychologist can lend valuable support include:

- Children at risk of sudden death
- Children having to learn to live with implanted devices such as pacemakers and ICDs
- Children who have had a cardiac arrest or who have seen siblings have a cardiac arrest
- Families where inherited cardiac disease has been diagnosed, possibly after the death of a family member
- Children with learning difficulties who require investigation or procedures
- Parents struggling to cope with any such situations

At the time of reporting, the role has become well established and is seen as an important component of the Royal Brompton's paediatric cardiac service. The Trust will provide funding for the post for two years, after which time it will be absorbed into statutory funding by the Royal Brompton.

Hampshire Wicket-keeping Programme

The Trust funded Hampshire Cricket Board's youth wicket keeping coaching programme for the sixth year. The Board believes that the quality of district and county wicket keepers has improved significantly and is a direct result of the programme and funding received from the Ben Williams Trust.

A strength of the programme is the training delivered to club, district and county coaches. This has created a legacy and has improved the quality of coaching keepers receive on a weekly basis.

The scope of the 2014 programme was temporarily reduced from that of previous years. It comprised six hours of coaching sessions for each of 14 boys and 14 girls with ages ranging from U10 through to U15 in the County squads.

Brief statement of the charity's policy on reserves

The Trustees have committed £100,000 over the two years from 1 April 2014 to fund the new paediatric clinical psychology post.

The remaining reserve of £69,499 is held to generate investment income and in anticipation of future activity in support of children with arrhythmia and youth cricket initiatives.
